- b. Zoning and Code Enforcement Clerk Stanley reviewed the permit list with the board in the absence of Building Inspector Crofoot. Most permits issued were for

the new construction on 1445 S. Fenmore. Also had one for a carport on Dice Rd and one for a pole barn on O'Hara Rd.

Stanley shared debt services looks high, but we are not over that line item and MTA dues is billed annually and looks like it is over due to the way it is broken down in payments.
- b. Lee Glazier resignation: Lee Glazier submitted a letter of resignation to the board with his final day being September 20, 2022. His resignation is due to being out of state 5 months of the year and feels that someone else could serve the community better. We thank Lee for his service on the board and he will be greatly missed.
