- VIII. Informational Items:
 - Board of Review will be held Monday, March 14, 2022 from 3 p.m. to 9 p.m. and Tuesday, March 15, 2022 from 9 a.m. to 3 p.m. The organizational meeting for the BOR members will be March 8, 2022 at 12:00 p.m.
 - Status of Litigation against the Township filed by Rochelle Siler Supervisor Brown informed board that it has been decided by the current Judge that this litigation should go back to the original Judge that held the first hearing. Nothing more on any court dates.
 - IX. Discussion Items:
 - We need to establish the date for the Budget Workshop meeting Supervisor Brown asked the board for available dates for the Annual Budget Workshop meeting. Discussion was held with the board members. The date of Monday, March 7, 2022 at 7:00 p.m. was agreed upon.
 - b. Supervisor Brown announced that he has received Christine Rames resignation as Assessor for the Jonesfield Township. Christine's resignation is as of May 1, 2022. Supervisor Brown will be working on getting a replacement – will be contacting Saginaw County Equalization office for suggestions for a replacement.
 - c. Supervisor Brown was in contact with the Jonesfield/Lakefield Fire Department and he will be receiving financials from the department as requested previously. He is suggesting a special meeting to be held with the fire department and Lakefield Township's board members along with our board members. More to come on this.
 - d. Roundtable for the good of the township Clerk Stanley announced to the board that she will be absent for the April 18, 2022 board meeting. Deputy Clerk Briggs will be in attendance in her place.
 - X. Action Items:
 - a. Resolution to appoint Larry Fleming as alternate BOR member for 2022 Supervisor Brown presented the board with a resolution to appoint Larry Fleming as an Alternate Board of Review member for 2022. This appointment comes due to the knowledge of Board of Review member Mike Kenny not being able to attend the March 2022 BOR meeting dates – he is going to be out of town. Discussion was held by board. Second offered by Trustee Nock to accept

resolution. Clerk Stanley held a roll call vote. Ayes – Brown, Parker, Nock and Stanley. Nays – none. Resolution adopted.

Resolution to Modify Guidelines for Poverty Exemptions from Property Taxes Assessor Christine Rames presented the board with a resolution to update the guidelines that are used for poverty exemptions from property taxes. Discussion was held by the board. Motion made by Supervisor Brown to accept resolution. Second by Treasurer Parker. Clerk Stanley held roll call vote: Ayes – Brown, Parker, Nock, and Stanley. Resolution adopted.
- Motion to pay bills Treasurer Parker made a motion to pay bills of General Fund \$12,486.64; Trash Fund \$4,574.56; Police Fund \$255.00; Wind Energy Fund \$156.00; Water Fund \$0.00. Total bills paid equal \$17,472.20. Second by Trustee Nock. Carried.
