The administration is placed in the hands of the township board, comprised of the supervisor, clerk, treasurer and two trustees which you elect to office.</p> <p style="text-align: center;">TOWNSHIP BOARD MEETINGS</p> <p>The regular monthly meetings are held the third Monday of each month. From November through April the meetings begin at 6:00 p.m. From May through October the meetings start at 7:00 p.m. Come and participate in your township's business. These meetings and any changes are posted on the township office window bulletin board and on Jonesfield.com.</p> <p style="text-align: center;">REAL ESTATE & PERSONAL PROPERTY</p> <p>Assessments are completed by March of each year by the Board of Review (BOR). You may appeal your assessment to the BOR at the March meeting(s). NO CASH PAYMENTS WILL BE ACCEPTED.
