TOWNSHIP ORGANIZATION

The community in which you live is organized under a township form of government. The administration is placed in the hands of the township board, comprised of the supervisor, clerk, treasurer and two trustees which you elect to office.

TOWNSHIP BOARD MEETINGS

The regular monthly meetings are held on the third Monday of each month at 7:00 p.m. Come and participate in your township's business. These meetings and any changes are posted on the township office window bulletin board and on www.jonesfield.com.

JULY BOARD OF REVIEW

The July Board of Review will meet on Tuesday, July 22, 2025, at 1:00 p.m. at the township office. Michigan statute allows review of qualified disabled veterans, property tax exemptions and correction of any errors brought to the Board of Reviews attention. Taxpayers will be heard on a first come first serve basis.

Qualified persons for tax deferment must remember to fill out the forms every year and return them to the Treasurer as soon as possible.

TAX PAYMENTS NOW BEING ACCEPTED ONLINE

You can now view and pay your tax bill online! Please go to the township website: www.jonesfield.com and look for the header: "Property Tax Information". Click on the "Pay Bill" link, where you will be directed to BS&A online, Jonesfield Township header page. Here you can search for your property using either your name, address, or parcel number. Once found, click on "view and pay". You have the option to create an account for future use by saving the payment information. Phone payments are also accepted. Dial **(989) 447-4336** and follow the prompts. Unfortunately, over the counter credit card nor cash payments can be accepted at this time.
