April 15, 2019

- IV. Approval of minutes from March 18, 2019 Board Meeting Treasurer Parker made a motion to approve meeting minutes. Trustee Nock second. Carried.
- V. Special Guest: Tara Mager, Merrill Community Schools Presentation Tara gave an excellent presentation on the state of the Merrill School System. All agreed that the success of the school and the community is dependent on community partnership.

VI. Reports:

- a) Treasurer General Fund \$92,149.41; Trash Fund \$70,835.48; Police Fund \$73,331.35; Water Project Fund \$274,728.51.
- b) Police Discussion was held again about the upcoming contract renewal and the other options that the township is pursuing.
- c) Zoning Jim Gray Zoning Administrator presented the board with the Active Complaint Log for Jonesfield Township and updated board members with the conversations he has had with the current township residents that he has been

working with. Also discussed the situation with the old Mike's Party Store property.

VII. Reports from Commissions/Boards/Committees:

- Planning Commission Trustee Nock reported on the April 9, 2019 meeting of the Planning Commission. Discussion on the clarification on the difference between a Police Power Ordinance and a regular ordinance. Shipping containers being used as storage units in the township – do we allow? Are they covered under any current zoning ordinances? The Planning Commission is also continuing their 5 year review of the current Zoning Ordinances. They are currently reviewing ordinances regarding fencing and farm animals. Next meeting is scheduled for July 9, 2019.
- Police Board Supervisor Tibbits and Village of Merrill Clerk, Jan Wazny, attended a meeting with Richland Township to look further into receiving police coverage through their township. Cost figures are being put together for us.
 Once we receive these figures, there will need to be a decision made Do we continue with Saginaw County Sheriff's department? Are they going to be willing to adjust their cost and supply a vehicle for the coverage? Or do we switch to having coverage supplied by Richland Township? Or do we dissolve the special assessment district and use the countywide Sheriff Patrol as other communities do.
- Waste Authority Supervisor Tibbits attended the latest Waste Authority
 meeting. Recycling was the hot topic of the meeting. Panel discussion was held
 on continuing of recycling and its value. Decision needs to be made by year end.
- Saga (GIS) Supervisor Tibbits attended the latest meeting of the Saginaw GIS user committee. It was announced that all zoning by county is beginning to be added to the website. Drainage Districts, Soil Erosion and Sedimentation Control is also being added to site. They are also looking into updating the website to include real time postings of property tax and comparable sales options.
