**REMINDER-** Tax payments can be made online.

Go to the township website: [www.jonesfield.com](http://www.jonesfield.com) and look for the header: **“Property Tax Information”**. Click on the **“Pay Bill”** link, where you will be directed to BS&A online, Jonesfield Township header page. Here you can search for your property using either your name, address, or parcel number. Once found, click on **“view and pay”**. You have the option to create an account for future use by saving the payment information.
