FROM THE DESK OF THE SUPERVISOR

The Chapin Road bridge has been replaced and is now open to traffic. A ribbon cutting event was help on Friday, October 25 to celebrate the long-awaited completion of this project. Senator Ken Horn joined the event and thanked residents for becoming involved in writing letters of support and lobbying for the need to get this bridge funded.

New three-year recycling contracts are now in place with Waste Management and American Waste who provide trash and recycling services from their headquarters in Traverse City. Our township residents will see no change in service or schedule. Recycling products should continue to be clean and single stream no sorting remains as an easy way to recycle. Remember that plastic shopping bags are not recyclable and if allowable materials like newspapers, etc. are in a plastic bag in the recycling container, the bag and its contents go to the land fill.

Hazardous waste drop-off days will take place again in 2020 to properly dispose of household items like paint, unused lawn chemicals, Styrofoam and other hard to dispose of items. It is likely that eight events will be held again. In 2019, the eight events yielded 2.5 tons of waste each time. When the drop-off dates are available for next year, they will be posted on jonesfield.com or you can visit recyclemotion.org after the first of the year. The location for these events is the Mid Michigan Waste Authority offices at 2063 South Miller Road, Saginaw.

The 2020 United States Census is just around the corner with the U.S. Census Office sending out mailings by April 1. The purpose of the census is to count everyone living in our United States of America. The census is taken every 10 years, and this is the first time we can respond in one of three ways; online, by paper form or by calling a 1-800 number. In todays age of privacy protection, people are more hesitant than ever about sharing information.

Why is it important to be part of the county? The 2020 population numbers will shape how political power and federal tax dollars are shared in the U.S over the next 10 years. The number of congressional seats and Electoral College votes each state gets are determined by census numbers. They also guide how an <u>estimated \$880 billion a year</u> in federal funding is distributed for schools, roads and other public services in local communities. The demographic data are used by businesses to determine, for example, where to build new supermarkets and by emergency responders to locate injured people after natural disasters.

What happens we if chose not to respond? We can probably expect trained census door knockers by early April with proper identification to conduct solicit census interviews and then collect our responses. Not being big on door knockers myself, we will probably just fill out the census as soon as we can and wait for the results.

Finally, the 2020 election cycle next year fills all township board seats for the following four years. I will not be running for another term as township supervisor after serving four years as a board trustee and the last three years as supervisor. It has truly been an honor to serve with the board for this wonderful community. As I shared with the board at our last meeting, this community is blessed with qualified and dedicated residents that can step up and serve in the supervisor position.

You can contact Marcia Stanley, Jonesfield Township Clerk for the application forms to get on the ballot. The various deadlines for filing the application papers are:

- **By 4 p.m., April 21, 2020:** Candidates for partisan office (township office) file nominating petitions and Affidavit of Identity for August primary.
- **By 4 p.m., July 16, 2020:** Candidates without political party affiliation (not running in primary) file qualifying petitions and Affidavit of Identity for November general election.
- **By 4 p.m., July 24, 2020:** Write-in candidates file declaration of intent for August primary.
