- VI. Reports: Planning Commission, Waste Authority, Saga (GIS)
  - a. Planning Commission October 6, 2020 meeting is scheduled. Agenda is finalizing the Master Plan and reviewing Special Use Permit submitted by Lee Glazier. October 13, 2020 meeting will be the regular quarterly meeting.
  - b. Waste Authority Zoom meeting scheduled for Thursday, September 24, 2020.
  - c. Saga (GIS) Meeting was held today, September 21<sup>st</sup>. Stanley Brown joined meeting. Saga is continuing to enhance their website.

#### VII. Informational Items

- a. DTE Special Use Permit Application Update Supervisor Tibbits discussed current standing of the Special Use Permit Application with DTE.
- Zoning Board of Appeals Public Hearing ZBA meeting scheduled for September 24, 2020 at 6:00 pm. Discussion will be on variances of height of turbines, property setbacks and application guidelines (one major application or one application per turbine.)
- c. Jonesfield/Lakefield Township Fire Board Supervisor Tibbits did some research and found that proposed budget for the fire board should be available 30 days prior to the meeting to be able to review. There should be two parts to the budget – one for operating and one for equipment. Discussion was also held on millage review procedures.

Jack's was the company we used to service our beer taps and lines. Clerk Stanley also announced that George Kipfmiller made mention to her that as of the first of the new year, he is planning to retire from Jonesfield Township as Building Inspector. Discussion was held on replacements.
- b. Draft Master Plan Comments from Board Brief discussion was held on Master Plan updates. Motion made by Clerk Stanley to accept Master Plan updates. Trustee Glazier seconded. Carried.
- c. Township Hall or Community Center Supervisor Tibbits announced that there has been talk of the Village of Merrill being interested in the Township Hall and to convert it into a Community Center. Discussion was held on this topic.
